HOW DOES THE ANNUAL AND MONTHLY PLANNING FOR EACH

TRAINER AT PREVIFORM?

At PREVIFORM, we don't work with annual or monthly training plans. Instead, our approach is flexible and tailored to the specific needs of each target audience. Here's how it works:

Each trainer is assigned short-term training units (UFCDs) of **25 or 50 hours**, depending on the training requirements. Before each UFCD begins, the trainer prepares a detailed session plan based on the content and objectives of that unit. This plan is then reviewed and **approved by the training coordination team**. Only after this approval do the training sessions officially start.

This method ensures that each training unit is relevant, wellstructured, and adapted to the learners' real needs.











WHERE DOES HE GET THE CONTENT FROM?

All training content is **defined by the National Qualifications Catalogue** (Catálogo Nacional de Qualificações) and is the same for every training centre and vocational school in Portugal.

What can vary are the lesson summaries and the teaching methodologies used by each trainer. Everything else — including objectives and content — is standardised and regulated.

The National Qualifications Catalogue (CNQ) is a comprehensive framework that defines all vocational training content in Portugal. It includes:

- 419 qualifications
- 5,381 competency units
- 8,075 short-term training units (UFCDs)

These standards ensure consistency and quality across all training centres and vocational schools.

HOW ARE SESSION PLANS MADE?

At PREVIFORM, all session plans are prepared digitally, using editable templates provided by the training coordination team.

Trainers complete these plans before the start of each UFCD, outlining the learning objectives, contents, methods, resources, and evaluation strategies.

Once completed, the session plan is submitted for approval by the coordination team. Only after approval can the training sessions begin.

This ensures consistency, quality, and alignment with the official training framework.


